1) Contest Period: The Kitchen For Exploring Foods (“The Kitchen”) two (2) passes to the LA Film Festival Social Media Contest (the “Contest”) begins at 5 PM Pacific Standard Time (“PST”) on June 1, 2017 and ends at 6 PM Pacific Standard Time on June 12, 2017 (the “Contest Period”).

2) How to Enter: Visit [thekitchen.net/lafilm](http://thekitchen.net/lafilm) or The Kitchen’s Facebook page between June 1, 2017 and June 12, 2017. Enter your email and like our Facebook and/or Instagram account. No purchase necessary in order to enter the Contest. One winner will be selected at random. The Kitchen will announce the Winner (“Winner”) on June 13, 2017, and the Winner will receive two (2) passes to the LA Film Festival to attend June 14-22, 2017. Winner is calculated from June 1, 2017 through 6 PM Pacific Standard Time on June 12, 2017 (the “Contest Period”).

By entering the Contest, each entrant represents, warrants and agrees that entrant is entering the Contest for himself or herself alone and not as part of a group (i.e., two or more) of entrants. Entries must not contain or depict any defamatory, obscene, sexually-explicit, abusive, harassing, hateful, discriminatory, threatening, or vulgar material and must be otherwise fit for publication, posting and uploading, as determined by The Kitchen for Exploring Foods in its sole discretion. The Winner will have one (1) business days to respond to such email and provide The Kitchen with a day-time telephone number and email where the Winner can be contacted in order to verify his or her eligibility to participate in the Contest. A selected entrant who does not respond to the email within two (2) business days will forfeit his or her prize, and the prize will be awarded to an alternate Entrant. The Winner will receive information on how to redeem the prize via email from The Kitchen.

4) Prize Details and Restrictions: The Winner will receive two (2) passes to the 2017 LA Film Festival. The two (2) passes may not be used for cash, taxes or gratuity.

Transportation to and from the participating location(s), surcharges, alcoholic beverages, taxes and gratuities are the responsibility of the Winner. In order to redeem the two (2) 2017 LA Film Festival passes issued to the Winner, the Winner must email The Kitchen back within one day of being contacted after June 13, 2017 (the "Prize Expiration Date"). To the extent that all or any part of the value of the passes credit has not been redeemed by the Winner prior to the Prize Expiration Date, Winner will forfeit the unredeemed prize in its entirety. The prize is nontransferable and no substitutions are allowed except by The Kitchen for Exploring Foods, which reserves the right to award a prize of equal or greater value if the awarded prize is unavailable.
